

**Hospice of Holland, Inc.**  
**2023 Hospice Regatta “Dinghy” Raffle (the “Raffle”)**  
**Official Rules (the “Rules”)**

**A PURCHASE IS REQUIRED TO ENTER AND WIN THIS RAFFLE.** The odds of winning are dependent upon the total number of Tickets sold during the Raffle Period (defined below).

**RAFFLE PERIOD:** The Raffle begins at open of business **July 10, 2023** and ends on or about **7:00pm** Eastern Standard Time (“EST”) on **August 19, 2023**

**ELIGIBILITY:** The Raffle is open to anyone eighteen (18) years of age or older (each, an “Entrant”). The Raffle is void outside the state of Michigan and wherever else restricted or prohibited by law.

**TO PARTICPATE:** in order to be able to participate for a chance to win the Prize in this Raffle, Entrants must purchase a Ticket. Tickets are available as a cost of twenty dollars (\$20.00) each, or six (6) for one-hundred dollars (\$100.00) and may be purchased by cash, check, debit card, credit card, cashier’s check, or money order. Tickets must be purchased via one of the following methods:

- Via the **Front Desk** at Hospice of Holland’s location at 270 Hoover Blvd., Holland, Michigan;
- From a **Hospice of Holland Employee**, or **Volunteer** who may be selling Tickets during the Raffle Period; or
- Via **Telephone** by calling (616) 396-2972 between the hours of 8:00 a.m. and 5:00 p.m. EST Monday through Friday during the Raffle Period.
- At **Yacht Basin Marina** located at 1866 Ottawa Beach Road, Holland, Michigan during business hours.

Upon purchasing the Ticket, Entrants must complete the lower half of the Ticket (the “Stub”) in its entirety, including his/her first and last name, complete mailing address, telephone number (with area code) and email address. Completed Stubs must be submitted to the representative from whom the Ticket was purchased. If you order by telephone, your Stub will be completed by the representative and mailed to you directly. Each Stub is considered one (1) entry into the Raffle. Each entry into the Raffle constitutes an equal chance to win.

Ticket payments may only be made in person or by telephone (via the telephone number listed above). Payments may not be made through the U.S. Postal Service or any other method other than what is listed within these Rules. A person is not required to purchase more than one Ticket and/or pay for anything other than the Ticket in order to participate in the Raffle or win the Prize. There is no limit to the number of Tickets a person can purchase during the Raffle period.

**WINNING:** The Raffle drawing will be held after **7:00pm** on **08/19/2023** at the *Hospice of Holland, 2023 VanderLeek Cup Hospice Regatta Fund Raising Event held at Yacht Basin Marina, 1866 Ottawa Beach Rd., Holland, MI 49424*. For the drawing, one (1) Prize Winner will be selected at random from among all eligible entries received during the Raffle Period. Odds of being selected as the Prize Winner will depend on the total number of eligible entries received. The random drawing will be conducted by the Sponsor

whose decisions are based upon their sole discretion and interpretation of these Rules and are final and binding in all respects.

**NOTIFICATION:** The Prize Winner need NOT be present to win. The potential Prize Winner will be notified by the Sponsor via email and/or telephone within twenty-four (24) to forty-eight (48) business hours of the random drawing. Potential Prize Winning notifications will not be left on answering machines/voicemail if notified by telephone. In the event that the Sponsor cannot reach the potential Prize Winner after two (2) attempts have been made, or it is determined by the Sponsor that the potential Prize Winner is not eligible in accordance with these Rules, an alternate Prize Winner will be selected at random from among the remaining non-winning eligible entries received during the Raffle Period and he/she will be notified as outlined above until one (1) Prize Winner is confirmed. Once confirmed, the Prize Winner will be required to complete the "Release" as defined in the "Prize Claims" section below.

**PRIZE CLAIMS:** Except where prohibited, the potential Winner must sign and return to the Sponsor, within fourteen (14) calendar days of receipt, an "Affidavit of Eligibility/Liability/Publicity Release form (the "Release") and pay all applicable state and federal income taxes in order to claim the Prize. If the potential Prize Winner fails to sign and return the Release and pay the required taxes within fourteen (14) days from receipt, the potential Prize Winner forfeits his/her right to the Prize and an alternate Prize Winner will be selected at random from among the remaining non-winning eligible entries received during the Raffle Period and he/she will be notified as outlined above until one (1) Prize Winner is confirmed. The Release must be completed and returned to the Sponsor and taxes paid prior to delivery of the Prize.

**TAXES:** The prize is taxable as income tax and is subject to sales tax and applicable title transfer fees. The estimated combined state and federal income taxes for the Prize, based on Fair Market Value, are: \$5,447.54. (NOTE: This is an estimate only. Actual tax liability may vary.) The taxable income will be reported to the IRS via Form W-2G. (Co-winners or someone claiming the prize for the winner must also complete an IRS Form 5754.) In the event it is deemed during the verification process that the potential Prize Winner does not have a unique, personal and valid social security number for the Sponsor to report the tax liability associated with acceptance of the Prize, the Prize Winner will be disqualified and another Prize Winner selected as outlined above.

**GENERAL CONDITIONS:** Should any portion of the Raffle be, in Sponsor's sole discretion, compromised by computer virus, worms, bugs, non-authorized human intervention, acts of nature, such as, tornado, flooding, or other natural disaster, or in the case of war, action of foreign enemies, terrorist activities, labor dispute or strike, government sanction, blockage, embargo, or failure of electrical service, or other causes which, in the sole discretion of the Sponsor, corrupt or impair the administration, security, fairness or proper play, or submission of entries, Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify, or suspend the Raffle and conduct the Raffle in a manner which, in its sole discretion, is fair, appropriate and consistent with these Rules. Notice of such action by Sponsor will be posted on its website as listed earlier. In such and event, Sponsor reserves the right to award the Prize, at random, from among the eligible entries received up to the time of impairment. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds in violation of these Rules or in an unsportsmanlike or disruptive manner. Sponsor reserves the right to disqualify or reject any incomplete, inaccurate or false entry. **ANY ATTEMPT BY ANY PERSON TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE RAFFLE MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAW, AND, SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW. SPONSOR'S FAILURE TO ENFORCE ANY TERM OF THESE RULES SHALL NOT CONSTITUTE A WAIVER OF THESE PROVISIONS.**

**RELEASE:** By participating in the Raffle, Entrants agree to release and hold harmless Hospice of Holland, Inc., and each of its officers, directors, managers, employees, parents, subsidiaries, affiliates, agents, members, shareholders, insurers, servants, divisions, predecessors, successors, and representatives (collectively, the "Released Parties") from and against any claim or cause of action arising from participation in the Raffle, receipt, redemption, or use of the Prize.

**LIMITATIONS OF LIABILITY:** The Released Parties are not responsible for: (a) unauthorized human intervention in any part of the entry process or the Raffle; (b) electronic or human error which may occur in the administration of the Raffle or the processing of entries; (c) any property loss, damage, personal injury or death, in connection with the Prize provided pursuant to this Raffle and/or any person's participating in the Raffle; (d) any printing or typographical errors in any Raffle-related materials; (e) stolen, lost, late, misdirected, corrupted, incomplete, or decipherable entries or the unavailability or inaccessibility of any transmissions, telephone, wireless device carrier networks, or internet service (if applicable); or (f) technical failures of any kind, including but not limited to the malfunctioning of any computer, mobile device, cable network, hardware or software.
